BYLAW NAME: GENERAL REVISION CONFIRMATION BYLAW

BYLAW #: # CS-28

BE IT ENACTED by the Council of the City of Summerside as follows:

PART I – INTERPRETATION AND APPLICATION

1. Title

1.1. This bylaw shall be known and cited as the “General Revision Confirmation Bylaw.”

2. Purpose

2.1. The purpose of this bylaw is confirm the revision to City of Summerside bylaws revised pursuant to Bylaw #CS-14 and section 134 of the *Municipal Government Act*, RSPEI 1988, c M-12.1.

3. Definitions

3.1. In this bylaw:

- (a) “Act” means the *Municipal Government Act*, RSPEI 1988, c M-12.1;
- (b) “Chief Administrative Officer” or “CAO” means the administrative head of a municipality as appointed by Council under subsection 86(2)(c) of the *Municipal Government Act*;
- (c) “City” means the City of Summerside;
- (d) “Council” means the Mayor and other members of the Council of the City;
- (e) “revision” or “revised” means to re-examine and make alterations to a bylaw in accordance with Bylaw #CS-14.

4. Confirmation

4.1. Council hereby confirms the revisions made to the following bylaws:

- (b) SS-06 Places of Amusement
- (c) SS-07 Traffic & Parking
- (d) SS-10 Right of Way Bylaw
- (e) SS-12 – Emergency Measures
- (f) SS-17 Firearms Bylaw
- (g) SS-21 Taxi Bylaw
- (h) SS-23 Parks Bylaw
- (i) SS-24 Staffing Bylaw
- (j) SS-28 Combative Sports Commission
- (k) SS-30 Cosmetic Pesticide & Integrated Pest Management

4.2. The bylaws listed in subsection 4.1 shall be repealed on November 18th, 2019.

4.3. The revised bylaws shall come into force on November 18th, 2019.

5. Effective Date

5.1. This General Revision Confirmation Bylaw, Bylaw# CS-28, shall be effective on November 18th, 2019.
