BYLAW NAME: Disposition of a portion of PID 1045053

BYLAW #: CS-32

BE IT ENACTED by the Council of the City of Summerside as follows:

1. Title

1.1. This bylaw shall be known and cited as the "Disposition of a portion of PID 1045053 Bylaw".

2. Authority

2.1. This bylaw is enacted pursuant to Sections 143 and 158 of the *Municipal Government Act*, RSPEI 1988. c M-12.1.

3. Criteria for Disposition

- 3.1. The following criteria shall apply to the disposition of a portion of PID 1045053 below fair market value:
 - (a) the grantee of the lands shall have made a commitment to develop the lands;
 - (b) the development shall promote economic development in the City and expand the City-owned recreation facility; and
 - (c) the development shall have the potential to increase unrealized commercial tax revenue in the City.

4. Disposition of a portion of PID 1045053

4.1. Council hereby authorizes the disposition of a portion PID 1045053, as shown and delineated on the drawing attached hereto as Schedule "A", to Tier Two Properties Ltd., for ONE DOLLAR (\$1.00) in consideration.

5. Effective Date

5.1. This Bylaw shall come into force and be effective on the date of approval and adoption by Council.


