Road Closure Bylaw

A Bylaw to Permanently Close a Portion of a Street described as Part of First Street between Summer & Central Streets.

Whereas in accordance with subsection 213 of the Municipal Government Act, RSPEI 1988, c M-12.1, the City of Summerside may by bylaw permanently close a street;

And whereas the Council of the of the City of Summerside deems it necessary to pass a bylaw to permanently close a portion of First street between Summer & Central Streets;

And whereas in accordance with subsection 213 (3) of the Municipal Government Act and subsection 3 - General Regulations, public notice of Council's intention to permanently close a portion of the First Street as shown on Appendix 'A' of this bylaw was published on January 9, 2021 in the Guardian newspaper and was posted on the City of Summerside's webpage and Facebook page;

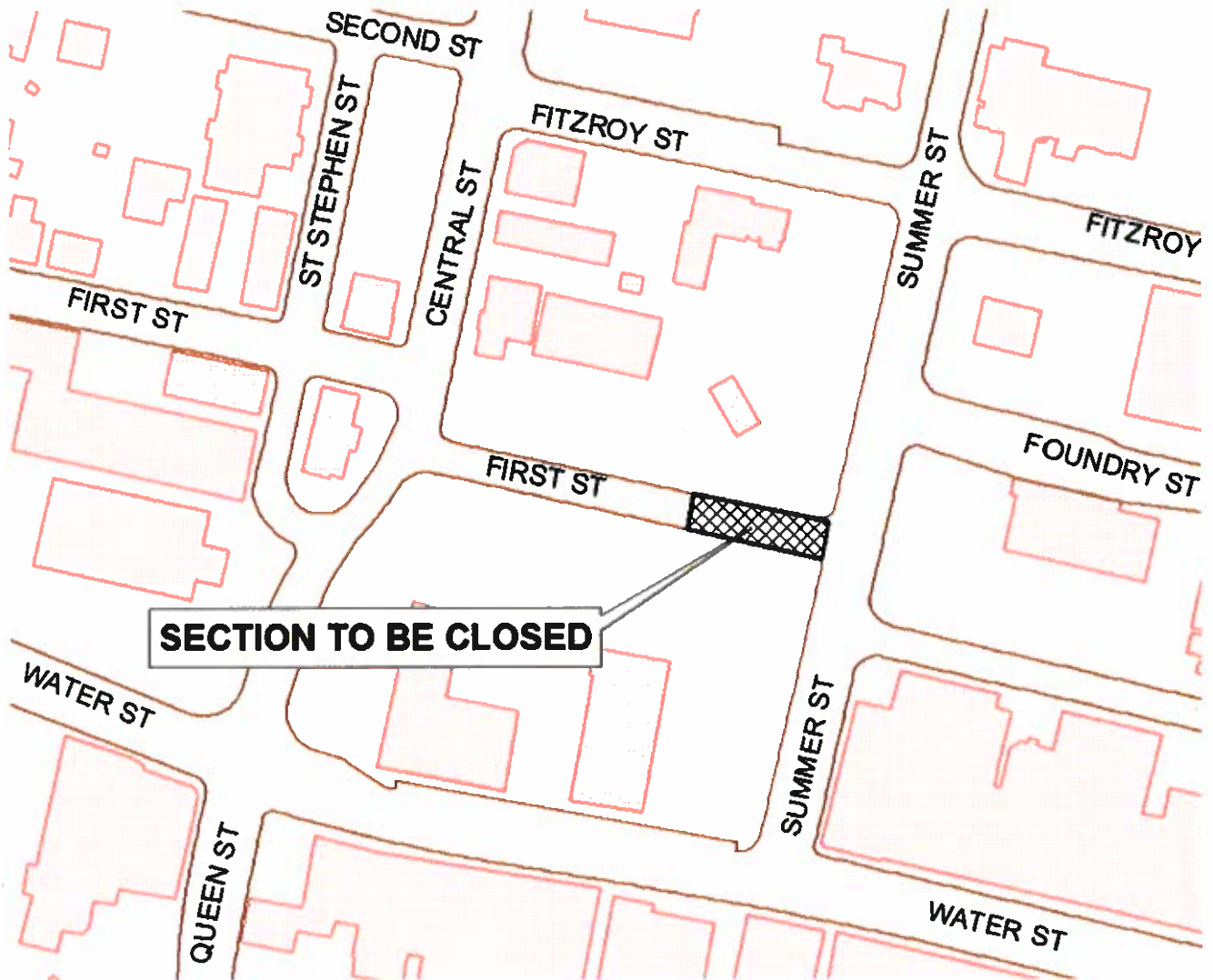
And Whereas in accordance with subsection 125 of the Municipal Government Act, copies of the proposed street closure bylaw have been made available to the public prior to and at the Council meeting;

And Whereas in accordance with Section 23.1 of the City of Summerside *Traffic and Parking Bylaw CS-27* "no person shall close any street or portion thereof without the written permission of the chief of police or his/her designate" and written permission has been received;

Therefore be it resolved that the Council of the City of Summerside hereby enacts as follows:

1. The portion of the street described as Portion of First Street between Summer & Central Streets shall be permanently closed, as shown on Schedule 'A' of this bylaw.
2. That a copy of this bylaw and certified legal survey plan be registered in the Prince County Registry Office.
3. That this bylaw shall come into force and take effect on the date of its registration.

Second Reading


This Portion of First Street between Summer & Central Street Road Closure Bylaw #CS-34, was read a second time at the Council meeting held on the 16th day of February 2021.
